

2. Name of the Trust:

The name of the Trust shall be "BAHUJANA HITAYA EDUCATION TRUST" and hereafter referred as 'the Trust' or 'BHET' in abbreviation. The Trust (BHET) shall operate as a non-political and non-profit charitable association.

### 3. OFFICE: -

The registered office of BHET shall be situated at Colonel House, Krishna Nagar, Agartala, West Tripura and it can be shifted to any part of India on a resolution passed by the Governing Body.

4. Ven. Dhammapiya, the author of the Trust Hander over Rs. 5,000/- to the Governing Body Trustees and they stand possessed the same. The amount shall be deposited in a Bank towards Corpus Fund of the Trust.

### 5. Objectives: -

- (a) To set up, maintain & run non-profit Public Charitable Educational Institutes.
- (b) To educate children from poor families irrespective of Caste, Creed & religion.
- (c) To sponsor students either partially or fully for their higher education.
- (d) To impart spiritual knowledge & train students on meditation.



- (f) To received and utilise donations & grants both movable & immovable from local & foreign sources.
- (g) To do all such things that deemed necessary for the welfare and development of the Trust.

# 6. Area of Operation: -

BHET shall have branch office anywhere in India as may be decided by the Governing Body.

# Rules & Regulation of-BAHUJANA HITAYA EDUCATION TRUST

- 7. (a) Any person of age 18 can become member of BHET on recommendation of a Trustee or regular member of the Trust.
- (b) Composition of BHET
- " BAHUJANA HITAYA EDUCATION TRUST" shall have the following composition:
  - (i) Chairman ·// (ii) Vice- Chairman.
  - (iii) Secretary (iv) Asst. Secretary.
  - (v) Treasurer (vi) Trustees, &
  - (vii) Members
- (c) The Governing Body shall induct members of various categories to the Trust from
- (d) The Governing Body shall have minimum 6 (six) and not more than 15 (fifteen) Trustees.
- (e) The Governing Body shall decide the number of upper limit of members if such a situation arises.
- (f) The Chairman shall select office bearers of the Trust and entrust duty with necessary power.
- (g) The Governing Body shall set up various branch office and Sub-Committees at different place for wider & smooth functioning of the Trust.

- The Governing Body shall have full power to issue directive and close down branch office and Sub- Committees if they become ineffective.
- (i) The Governing Body shall decide membership fee and may revise from time to time.
- (j) No part of assets or property of the Trust shall be shared among Trustees & members by way of profit.
- (k) In the absence of Chairman & Vice-Chairman, the remaining Governing Body Trustees may elect a Chairman from amongst themselves only for that particular transaction & meeting in case of emergency. At the closure of the meeting, the temporary Chairmanship shall be invalid.

### 8. POWER & DUTIES:

### (a) Chairman:-

- (i) The Chairman shall have supreme and discretionary power in decision making on all matters of the Trust & his decision shall be final.
  - (ii) The Chairman shall preside over all meetings of the Trust.
  - (iii) The Chairman can suspend & remove any Trustee or member if found involved in anti-BHET activities, and guilty of corruption, mismanagement of funds and moral turpitude.
  - (iv) The Chairman can also re-instate the suspended or dismissed person if he or she tender an apology verbally or in written to the Chairman at the Governing Body meeting.

### (b) Vice- Chairman:-

The Vice-Chairman shall preside over all meeting in the absence of Chairman and take decision in consultation with Chairman on important issues.

### (c) Secretary: -


The Secretary shall -

- (i) sign on all receipts, bills and on all necessary documents on behalf of the Trust.
- (ii) maintain all office files, Register books, other relevant documents & records.
- (iii) serve notice to all members of Governing Body at least 24 hours in advance to convene Governing Body meeting.

- (iv) circulate notice to all Trustees and members 15 days before the date of commencement of Annual General Meeting.
- (v) do official correspondence on behalf of the Trust.
- (vi) keep all necessary files and documents open for inquiring about the activities and progress of the Trust.
- (vii) deal with all legal cases on behalf of the Trust for or against BHET.

# (d) Asst. Secretary:-

The Asst. Secretary shall assist the Secretary for all necessary works and shall carry out the duties of Secretary in the absence of Secretary.


- (e) Treasurer: The treasurer snall maintain proper account of the Trust.
- (f) Trustee: The trustee shall assist and co-operate the Governing Body for development and smooth functioning of the Trust. The Trustees can make suggestions and participate in decision making at the Governing Body Meeting.
- (g) Patrons & Members: The patrons and members of BHET can avail various facilities of the Trust which shall be announced by Governing Body from time to time. Any member of the Trust and go through the records if so desired on written application to the Secretary.
- 9. Accounting Year: The accounting period shall be from February to March every financial year.
- 10. The bank account shall be operated by any two of the following:
  - (i) Chairman (ii) Secretary & (iii) Treasurer
- 10. Under any circumstance if the Trust is dissolved, the movable and immovable assets & properties shall not be distributed among the Trustees and members the Trust. After winding up of the Trust, the remnants (remaining assets & properties) shall be donated to any other organization with similar objectives.
